The Company has 248,736,588 ordinary shares in issue. In general, there are no restrictions on the sale or transfer of the Company's shares. The Company has 32,708,252 warrants on ordinary shares in issue, all of which were granted to warrantholders in conjunction with their subscription for equity units of the Company. In addition the Company has 11,746,000 employee stock options outstanding. On a fully diluted basis (i.e. if all warrants and options were exercised) there would be 293,190,840 shares in issue.
